TERMS

The minimum deposit under this scheme is ₹40,000, with tenure options of 1, 2, 3, 4, or 5 years. The applicable interest rate is 10% per annum for general citizens and 10.5% per annum for senior citizens aged 60 and above, subject to valid age proof. Investors may choose their preferred interest payout mode—monthly, quarterly, annually, or on maturity—at the time of opening the account, which cannot be altered later. Deposits may be made through cash, cheque, or bank transfer as per company policy.

Premature withdrawals are permitted only after completion of 12 months from the date of deposit; in such cases, the interest rate will be reduced by 2% for the completed period, and no interest will be paid if withdrawn before 12 months. A nomination facility is available, with one nominee permitted per deposit. Investors may also opt for automatic renewal of their deposit at prevailing rates upon maturity.
